Full Certification through the Gómez & Gómez DLE-TOT Institute requires completion of Phase 1 & 2

Phase 1: Participant will complete 5-Day DLE-TOT Institute

Phase 2: DLTI will co-train with candidate, observe candidate training, and conduct DLE classroom visits to assess candidate training & certify for 3 years

The following fees are **per participant** and subject to eligibility requirements below:

Phase 1: 5-Day DLE TOT Institute (recommend 2 per ISD)..... \$1,995.00 (per participant)

*Note: DLE-TOT Institute Fees include 5-Day DLE-TOT training, materials & binder, daily breakfast & lunch, and afternoon snacks. **Lodging and travel NOT included.** Participants make own reservations directly with Hyatt Regency Hotel and identify themselves as participants of the Dual Language Training Institute. Phase 2: DLTI Full Certification (contracted across 2 years)..... \$8,500.00 (plus consultants' travel expenses)

*If seeking **Full Certification** for any participant listed below, Phase 2 is **contracted separately** (across two years) through **DLTI within 24 months** of completing Phase 1 of the Gómez & Gómez DLE-TOT Institute. Phase 2 must be completed as follows:*

1. DLTI consultant and TOT candidate "co-train" a 3-Day DLE training - \$3,000 (\$1,000 per day)
2. TOT candidate conducts 3-day DLE training and DLTI consultant observes - \$3,000 (\$1,000 per day)
3. DLTI conducts classroom visit in classrooms that candidate provided training - \$2,500 per candidate (will visit up to 16 classrooms per candidate)

Eligibility Requirements for Full Certification on Gómez & Gómez DLE Model:

- Participant is an employee from a district or school outside of the State of Texas and has implemented the Gómez & Gómez DLE Model through 1st grade, and DLTI has provided training, technical assistance and conducted classroom visits within the past two years, or
- Participant is an employee from a Texas district or school that has implemented the Gómez & Gómez DLE Model through 5th grade, and DLTI has provided training, technical assistance and conducted classroom visits within the past two years.
